My research interests include party systems, elections, and ethnopolitics in European countries. In doctoral dissertation and monograph, I investigated how electoral competitions among ethnic majority parties affect public policies and the political actions by ethnic minority groups, with statistical analysis in the Central and Eastern European countries and in-depth comparative case studies in the two Baltic republics –Estonia and Latvia. Some of my past works paid attention to anti-immigrant sentiments in post-Communist Europe. My current project evaluates the effect of electoral vicinity and party mobilizations onto peoples sense national attachment, national pride, and related political feelings. As extensions of my research interest onto party politics and elections, I have several journal articles and chapters about voter participation, electoral management, intra-party politics, and so on. These made me accumulate experiences to direct and organize original survey poles in several countries. My researches offer broader implications for the considerations about nation-building and ethnic issues in the democratic political processes.
